EXECUTIVE SUMMARY

Prada, faced with the challenge of standardizing the management of recurring contracts across the entire Group, has chosen to rely on the **Akeron RCM** solution. This decision has translated into significant specific process benefits:

THE CHALLENGE

With 641 directly managed stores in over 40 countries, Prada Group needed to structure a unified process to manage all rental contracts. The ultimate goal? Transform the regulatory obligations of IFRS 16 into a chance to grow and innovate.

To do so, the solution had to standardize the management of contractual information on a global scale, as well as to provide all the accounting information for the month-end financial closing form the entire Group.

Furthermore, these evolutions had to be pursued together with a flawless integration with the SAP ERP system already in use in the group.

- The freeing of offices from manual tasks.


RESULTS & FUTURE PLANS



In addition, the Akeron solution represents a single interface for entering the rental and leasing invoices of all the Group's companies, thus becoming an automatic feeding source for the SAP transactional system implemented in the company. Besides the value of the results already achieved, some add-ons have emerged in the meantime as future enhancements of the initial project. In particular for the Italian market, where the Prada Group concentrates its production, the possibility of integrating the EDI flows for e-invoicing would certainly result into freeing resources that could be used in more strategic activities.

For the same purpose, but with obvious benefits for all countries, payments will be directly issued through Akeron RCM.
